1. An election is to be held for **ONE PARISH COUNCILLOR** for the **WYBUNBURY PARISH COUNCIL**.
2. **Nomination papers must be hand-delivered to the Returning Officer, Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, on any day from the date of publication of this notice; Monday to Friday between the hours of 10.00am and 4.00pm (excluding bank holidays) but not later than 4.00pm on Wednesday 2 April 2025. Please telephone 01270 685922 to make an appointment to deliver your nomination paper.**
3. Nomination papers may be obtained in person from the Returning Officer, Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, between the dates and times stated in paragraph 2 above. Written requests for nomination papers must be posted to our postal address: Elections Office, Ground Floor, Macclesfield Town Hall, Cheshire East Borough Council, Delamere House, Delamere Street, Crewe, CW1 2LL.
4. If the election is contested, the poll will take place on **Thursday 1 May 2025 between the hours of 7.00am and 10.00pm.**
5. Applications to register to vote must reach the Electoral Registration Officer **by 12 midnight on Friday 11 April 2025**. Applications can be made online: <https://www.gov.uk/register-to-vote>
6. Electors and their proxies should take note that:
 - a) Any changes to, or cancellations of, existing postal or proxy vote records, must reach the Electoral Registration Officer **by no later than 5.00pm on Monday 14 April** if they are to be effective for this election.
 - b) New applications to be treated as postal voters, must reach the Electoral Registration Officer **by no later than 5.00pm on Monday 14 April** if they are to be effective for this election. Applications for a new postal vote can be made by way of paper application or online at www.gov.uk/apply-postal-vote
 - c) New applications for proxy voting arrangements must reach the Electoral Registration Officer, **by no later than 5.00pm on Wednesday 23 April** if they are to be effective for this election. Applications for a new proxy vote can be made by way of a paper application form and in certain circumstances applications for a new proxy vote can be made online at www.gov.uk/apply-proxy-vote
7. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer **by 5.00pm on Wednesday 23 April 2025**. Applications can be made online: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
8. Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer **by no later than 5.00pm on Thursday 1 May 2025** if they are to be effective for this election.
